President's Report

Dear Mosman Rowers Members.

During the year to 31st March 2023 the Board and Club Management have focused on the following:

- > Complying with the terms and conditions of the Roads & Maritime Services (RMS) Agreement for Lease (AFL) and securing the the 20 year Lease. Establishing systems for compliance with the Independent Liquor & Gaming Authority (ILGA) license requirements and the Registered Clubs Act.
- Securing a long-term lease with Mosman Council
- Paying out all loans related to clubhouse refurbishment
- > Structural improvements to the Clubhouse including installing solar power.
- Continuing the work of our various committees and advisory groups to ensure focus on key strategic initiatives and sustainable programs at the Club.
- > Enhancing our member engagement and communication.
- Working to drive membership growth.
- Reviewing the annual events calendar to foster sporting, social and family events.

Early in this period we were delighted to welcome our new General Manager Tom Woods who joined us with great experience in hospitality including at the Buena Vista. Tom joined the team and quickly brought a renewed energy, a refocus on members and on rebuilding a new locals centric Rowers crew. Over the period he has worked tirelessly with the operations team to rebuild our Rowers crew after we were impacted by the hospitality crisis in 2022. An additional focus was on reinvigorating the food options for members and providing more member and community activities from our Club, building on our vision of being the Community hub in the lower North Shore.

As of 31 March 2023, total membership was 1,148. During the period many members have joined and renewed, although we are finding it more difficult to encourage renewal and are actively working to achieve this. Due to the continuing impacts of COVID-19 we reduced annual membership fees to \$60. The decision was driven by member feedback and the need for the Club to have every adult in a family be a member not just one person. Member numbers ensure compliance but also are a significant driver for grants so it is very important that we as Members, try to encourage everyone to become a member.

As a Club, we are indebted to Julie Dalgliesh, a Life Member, who has dedicated countless hours to improving, managing and coordinating our membership program. Julie was working closely with Clubs NSW to ensure improvements but this proved far more challenging than anticipated and we are still trying to find a membership system to upgrade to that will not only interface seamlessly with all our legal requirements under the various NSW Acts, our point of sales and other communication systems used by the Bird & Bear group but also be much easier for members to sign in to the Club, track their membership and renew. Our focus remains ensuring we engage both our new and long-term Members so they are actively part of the Mosman Rowers community and culture.

The Social and Membership Committee, convened by Linda Holub, continues to work diligently to achieve this, supporting and initiating many activities. Working with the Bird & Bear Events team, we have maintained a good weekly schedule of activities for members and guests including our ever popular weekly Friday raffle which is now teamed with a paella dinner special and augmented for special occasions like Easter and Mothers' Day weekends. Classes such as health and fitness classes, community choir, mums & bubs, bridge and mahjong have continued; our *In Conversation@The Rowers* series; Trivia has been a monthly offering but will revert to weekly; the hugely popular *Jazz@The Rowers* continues monthly, and our highly successful, *Art@TheRowers*, led by Gill Burke, has been a wonderful initiative that has generated substantial Club revenue and which we hope will continue to grow.

We warmly congratulate all the selected artists, and winners, in particular Jessica Ashton, whose painting was acquired and hangs in the Club in perpetuity. We sincerely thank all who continue to support this very worthwhile initiative: those who submitted their work; those who attended, admired and bought many of the works. We are especially grateful to our major sponsor Richard Crookes Construction; our wonderful judge the highly acclaimed Australian artist Ben Quilty; the selection panel: Susan Baran, Kate Lovejoy-Furnell with Social Committee and Board representatives; Damien Thompson, Neimad Picture Solutions for extension of our professional track system, ArtSmart for discounted framing, and sponsoring the Members Choice award; and our small band of hard working volunteers who planned, managed and ran the exhibition again. This year the Art committee also initiated Exhibitions@TheRowers which offers individual, or groups of artists an opportunity to exhibit their work for sale during our generally quite winter period. We have had more enquiries than we could accommodate because exhibition space is a scare commodity. We are trying to balance space in the calendar for other social events to be booked. Like Art@The Rowers, these exhibitions provide income from sales to the Club. Again, this is thanks to the dedication of Gill Burke and a small group of helpers. Without our volunteers the Club simply would not be a thriving community resource and we would not have had such a productive year. Fittingly, Gill was acknowledged as the 2022 Rowers Member of the Year. In addition, our monthly newsletter, Rowers Reel, is produced by the Social Committee, with special thanks to Steph O'Connor whose desktop publishing skills have until recently, turned the content into our interesting newsletter, keeping members informed about all the offerings at the Club.

We are of course, indebted and extremely grateful to our wonderful Rowers staff team. They have been our rock, consistently working hard through all the challenges to ensure the Club remains not just open but vibrant, ensuring all our Members and guests feel special and welcomed. Thanks to our staff, we not only enjoy breakfast, lunches, dinners, drinks and special occasions like birthdays and weddings, overlooking our beautiful Mosman Bay. We are also spoilt being able to celebrate Christmas, Australia Day, ANZAC Day, Mothers' Day and other key occasions like school holidays, the Melbourne Cup bringing together members, friends and family. We have been very pleased to be able to continue our Dining Differently@The Rowers series and plan many more showcasing our suppliers and our talented chefs. I particularly want to acknowledge and thank our management team, led by General Manager Tom Woods and Shane Mansfield, Chief Operations Manager, until his departure late last year, Bird & Bear, and their team for their continued inputs. I would like to mention Jimmy Hazelwood who has been with us since the beginning, congratulate him on a promotion to assistant manager and thank him for his continued support of the Club and his musical talent which we are able to showcase. Together the staff team have overseen the ongoing successful development of the Club, despite all the difficulties of the period, supported by Emma & Adam Marshall, in our fourth year of trading under the 'new era'. The key challenge was of course ongoing COVID 19 impacts for many months. The entire hospitality industry has faced the same challenges, key amongst these continues to be the severe shortage of skilled staff. This has been a very difficult period for staff who managed the process very professionally, returning to an energetic and fully engaged Club. However, it has meant we are still unable to be open 7 days from early til late, but we are working towards this. We will resume an earlier weekend breakfast service as soon as possible.

I also want to reiterate my personal thanks to the commitment, focus, support and hard work of all our Board members, each and every one has dedicated and invested significant time, energy and resources into the Club, with regular meetings, supporting our committees and our staff. Working to achieve our goals and to remain viable requires many, many hours of volunteer work. Few understand just how many hours this requires. The Board has continued working hard to achieve our vision of establishing the Mosman Rowers as THE key Community hub in the Mosman area. Our Grant strategy and submissions continue with a successful grant last year for a solar system thanks to a NSW Community Partnership grant. Our sincere thanks to our State member Felicity Wilson, MP for her support. The understandable focus of many grants on communities affected by fire, floods and COVID has made it much more difficult for us. in the previous year we received government funds for a Defibrillator. This is a critically important resource that has been used on several occasions, undoubtedly instrumental in reducing risk to life for the people involved who were experiencing serious health traumas while visiting the Club.

We continue working closely with and enjoying the strong support of the Mosman Council to enhance our Club and Mosman Bay, and helping us reduce our impact on the environment. We are very grateful to Mayor Carolyn Corrigan for all her support and hard work, and to Councillor Simon Menzies for his continued guidance with key issues.

Additionally, I would like to thank our Federal Member, Zali Stegall AO and the Clean Up Australia team for their continued support and enabling us give back to the community. We have supported several local charity groups with fundraising functions, including a big Ukrainian fundraiser, we and have hosted community forums.

Clubs are important avenues for people to feel socially connected, to feel like they belong and have support and community around them. Our aim is to ensure our beloved Mosman Rowers is a place where everyone enjoys a sense of connection, engagement as part of our community, ensuring everyone's experiences are very positive and inclusive.

Thank you once again for being a member of our fabulous Club, and we look forward to seeing you all at the Club again soon.

Our dedication to improvement is evident through our partnerships, such as teaming up with leading coffee supplier Allpress Espresso to improve our coffee experience and revamping our wine list to feature a diverse range including biodynamic and organic selections as well as premium options like Chablis and Barossa Shiraz.

Key achievements over the year include:

- Digitising our checklists to enhance team training, support and compliance programs

- Successfully trialling our first off-site market stall at Mosman's Dogs Day Out event at Reid Park, extending our reach with the local community
- Installation of the Giant screen in the Rowers Bar alongside the re-launch of our 'Live & Loud' campaign, solidifying the Rowers' reputation as one of Mosman's premier Sports Bars.

As we look ahead, our Marketing and Events Head Tegan is steering a forward-looking marketing plan with enthusiasm, with more exciting events and activations for our members and regulars in the pipeline.

Once again, we'd like to extend our thanks to the Club Directors and many volunteers that work with us to deliver some very special member experiences. During the year many new members have joined and many have renewed, although we are finding it more difficult to encourage renewal and are actively working to achieve this. Following closures due to COVID-19 we reduced individual annual membership to \$60. The Social and Membership Committee has been working hard to ensuring better communication via the newsletter, and engagement of our members with regular activities, offered at discounted prices to members. We are indebted to Julie Dalgliesh, a Life Member, dedicating countless hours to improving, managing and coordinating our membership program. Julie was working with Clubs NSW to ensure improvements but this has proven more challenging and complicated than anticipated. We want to make it easier for our members to join and renew. We continue to work on plans to evolve the system and its integration into marketing, point of sale and other programs to enable us to better communicate with all our members via newsletter, emails and ensure we understand everyone's needs, and providing the best member experience. The ease of renewal and joining through the website has cut the number email queries.

Annual membership fees are essential to cover the Club's member and corporate costs, in addition to funding special projects such as equipment purchases, supporting sporting and social activities, and essential repairs to name just a few.

We continue to work to attract new Members to the Club and ensure the culture of the Club as a family centred, community hub.

A critical element of our success is for Members and their families to feel a sense of pride and belonging at the Rowers, a feeling that this is their Clubhouse. To achieve this the Board together with the Social Committee have spent a significant amount of time developing and running member centric programs such as the Mosman Rowers fitness classes, art exhibitions, mah-jong, , and many more. We seek the support and help of our members to participate in these programs and ensure we continue to build a sustainable Membership-based Club at the Rowers. We will have Volunteer nights listed on our website to better understand how you can make sure our Club continues to become even better.

Social Report

Mosman Rowers Social Committee, led by Linda Holub, continues to be very active. The ever-popular Friday night meat raffle with support from Meat on The Avenue, and Best Fruits on Military Road has gone from a break even enterprise 'just for fun' to one that helps generate needed resources for the Club. The Social Committee raffle subcommittee is led by Fiona Byrne who ensures we have our volunteer ticket sellers every single week, supported by the wonderful stalwart Peter Francis who never fails to turn up and impress. During a bout of poor health when Peter was not able to do his weekly stint, our long-time member and local Councillor, Simon Menzies stepped up into Peter's role. Many thanks both. It is a very big commitment, and the Board is indebted to everyone involved in making this a key weekly activity and attraction. We have also introduced extras for special weekends such as chocolate eggs and seafood platters for Easter, champagne and gifts for Mothers' Day, hams for Christmas. In the past financial year, the Friday raffle has turned over more than \$29,000, generating over \$10,000 in profit for the Club. This has been a fantastic joint effort, with all funds going directly to ongoing improvements to the Club.

A number of other regular activities include weekly fitness classes, mums & bubs yoga and catch ups, mahjong, community choir, and yoga. These change from time to time. Monthly Jazz@The Rowers, which features local members and special guests each month, remains very popular, and we are proud to be supporting the creative arts. We have had several other live music events supporting our own, very talented staff, Jimmy Hazelwood, Zac Harvey and Zac Newton-John.

Trivia with a Twist also continues as a popular evening mid-week thanks to John Ed Molyneux for his great support of the Club and style as Trivia Master. In Conversation@The Rowers guest speaker series has continued and we thank our wonderful guest speakers, including a talk from local artist Michele Arnott who was winner of the previous years' Art@The Rowers. Michelle took us through the trials and tribulations of being a practising full-time artist. We have also all enjoyed the return of Dining Differently@The Rowers and hope to make it a more regular feature.

The Social Committee also supports other events at the Club including Australia Day, Mothers' and Fathers' Day, ANZAC Day, the Melbourne Cup, and running the Members' and kids wonderful Christmas parties, hosting members and families to a great Christmas party complete with Santa and gifts as a great way to end the year.

Our impressive Art@The Rowers, organised by 2022 Member of the Year, Gill Burke and the Social Committee, was again a great success, generously supported by the Archibald winning artist Ben Quilty as the judge, and prizes generously sponsored by Richard Crookes Constructions. The exhibition was again a success with over 100 entries. The winning entry was a beautiful oil painting, of Collins Beach (Kayoo-may) by local artist Jessica Ashton. We are delighted that Art@The Rowers is growing quickly in both reputation and popularity. We congratulate and thank all involved.

Following our highly successful second *Art@The Rowers* we were delighted withthe introduction of the new series of *Exhibitions@The Rowers*. The series started in April this year with The Press Gang, a diverse group of Printmakers and Photographers based in Sydney and London. It includes our talented Gill Burke who not only received 2nd prize at *Art@The Rowers* but also the Members' Choice Award. Congratulations Gill.

The monthly newsletter Rowers Reel, is very popular, keeping members informed and in touch with what's on. The Board sincerely thanks those who regularly assist. The Risk & Compliance Advisory Committee previously a separate committee, now included in the Board agenda, covered all aspects of the Mosman Rowers Club, with the key areas covering:

- Liquor Act and other statutory requirements of The Independent Liquor & Gaming Authority
- Registered Clubs Act
- Transport NSW (previously Roads and Maritime Services)
- Occupational Health and Safety

Since May 2021 these matters are routinely managed by the Operations Committee and as necessary, by the Building Maintenance committee with an additional layer of governance by the Board

These include:

- First aid training for staff and volunteers
- All aspects of food safety
- Work Place Inspections
- Cash Handling
- Fire and Emergency
- Review of Mosman Council and RMS lease agreements
- Review of Mosman Rowers insurance policies
- Fire and safety requirements.
- Incident log and report maintenance
- Complaints Handling

In addition we have a Compliance Checklist and spreadsheet covering the Standard Operating Procedures.

Building Report

Like all old buildings, repairs and maintenance continue to be a burden for our Club. We received a grant for the installation of solar panels to help with our energy consumption.

We have a number of additional work items to complete including:


- The rubbish bin area, upgrade repair and ensure aligns to the local environment

- Repairs to decks, stairs and walkways
- Kitchen painting and repair
- Bathroom upgrades
- Accessible access viability review
- Port Bed Clearance report
- Harbour sub-division for TfNSW long term lease compliance

The big-ticket item currently being completed are the substructure repairs including upgrading and replacing of older piles under the building, as a requirement for our 20 year lease with Transport for NSW, the walkway along the northern side of the building, and completing the upgrade of the kitchen floor.

The Building committee is open to any members that can help by either providing services, guidance or materials as we move forward with our plans

Grants Report

During 2022- 2023 a few relevant grants were identified with several applications submitted. During this time, we received funds to install solar panels during 2023.

We acknowledge and are most grateful for the support of both Ms Felicity Wilson, MP, State Member for North Shore for funds through the NSW Community Building Program, and to Ms Zali Stegall OAM, MP, Federal Member for Warringah.

We continue to apply for State and Federal funds for maintenance work on piling supporting the building; upgrading bathrooms and improving accessibility including lift access to the lower level. We also have applied for support from Mosman Council to ensure the Club is environmentally responsible. This includes keeping food waste out of landfill, moving away from use of single use food and drink containers, especially coffee cups and plastics and beautifying the approach to Club, in particular the waste storage and delivery areas.

Directors' Report

The Directors have pleasure in presenting the Financial Reports of Mosman Rowers Limited (the Club) for the period ended March 31st, 2023, and the Auditor's Report thereon.

We are pleased with the result for the year, being an operating profit of \$279,410 (\$344,151 for 2022 Including \$240,000 of Government grants and rebates), which includes a fee of \$50,000, being part of a Licence fee to manage the retail operations of the Club.

Notes to Accounts

1. Company limited by guarantee

The Club is a Company limited by guarantee under the *Corporations Act 2001*. The amount of Capital which is capable of being called up in the event of, and only for the purpose of, a winding up of the Club, is not to exceed \$10 per Member by virtue of the Club's Constitution.

2. Statement of significant accounting policies

The significant policies which have been adopted in the preparation of this financial report are:

a) Basis of preparation

The Financial Report is a general-purpose financial report which has been prepared in accordance with the Australian Accounting Standards and the Corporations Act 2001.

It has been prepared on the basis of historical costs and except where stated, does not take into account changing money values or current valuations of non-current assets.

The financial report has been prepared on a going concern basis, which contemplates continuity of normal business activities and the realization of assets and liabilities in the ordinary course of business. The going concern of the Club is dependent upon it maintaining sufficient funds for its operations and commitments. The Club made a profit of \$279,410 during the period ending 31 March, 2023 and the Directors are very pleased with this result given the difficult trading conditions following on COVID-19. They have been conservative in the cash forecast for the next 12 months because of continuing uncertain economic conditions, however, the Directors believe that the Club will be able to continue as a going concern and as a result the financial statements have been prepared on a going concern basis.

b) Statement of compliance

The Financial Report has been prepared in accordance with the Australian Accounting Standards (AASBs) adopted by the Australian Accounting Standards Board (AASB).

c)Cash and cash equivalents

For statement of cash flows and balance sheet presentation purposes, cash and cash equivalents includes cash on hand.

d) Revenue recognition

Sales revenue

Sales revenue is recognised when the goods are provided, or when the fee in respect of services provided is receivable.

Subscriptions/Memberships

Subscription revenue is recognised in the period to which the membership relates.

Grant income

Grant revenue is recognised in the income statement when the entity receives the grant or when it is probable that the entity will receive the economic benefits of the grant and the amount can be reliably measured.

If the grant has conditions attached which must be satisfied before the entity is eligible to receive the grant, the recognition of the revenue will be deferred until those conditions are satisfied.

Where the entity incurs an obligation to deliver economic value back to the grant contributor, the transaction is considered a reciprocal transaction and the revenue is recognised as a liability in the balance sheet until the required service has been completed, otherwise the income is recognised on receipt.

Donations income

Donation income is recognised upon receipt of the donated monies.

Licence fees

Under the terms of the agreement the Club entered into with Ashdown (Archie Bear) Pty Limited in April 2019 there was a payment received for the sum of \$500,000 which was applied toward the costs associated with the new fit-out to the Club's premises. In accordance with Australian Accounting Standard AASB 15 - 'Revenue from Contracts with Customers' - the payment of this sum has been treated as the creation of a performance obligation. As the amount is non-refundable and the term of the agreement is for 10 years, then in accordance with the requirements of the Standard the revenue derived from the performance obligation will be recognised over the full term. The adoption of AASB 15 has resulted in a change in the treatment of the Deferred Revenue amount on the Balance Sheet. In the year ending 31 March 2019 the full amount of \$500,000 was shown as a Current Liability. With the change of accounting treatment only the revenue to be recognised in the 12-month period ended 31 March 2023 is treated as a Current Liability and the balance has been transferred to a Non-Current Liability account.

e) Income tax

No provision for income tax is necessary in respect of Club trading and investment income because the income is exempt from tax under the relevant provisions of the Income Tax Assessment Act.

f) Property, plant and equipment

Depreciation

Items of property, plant and equipment are depreciated using the straight-line method over their estimated useful lives. Assets are depreciated from the date of acquisition.

g) Employee benefits

- i. Liabilities for wages, salaries and annual leave are recognised for employee benefits in respect of employees' services up to the reporting date and are measured at the amounts expected to be paid when the liabilities are settled, plus related on-costs.
- ii. The liability for long service leave expected to be settled within 12 months of the reporting date is recognised and measured in accordance with (i) above.

The liability for long service leave expected to be settled more than 12 months from the reporting date is recognised but is measured based on remuneration rates current as at balance date for all employees and based on the probability of each of them achieving ten years of service.

The directors believe that this method provides an estimate of the liability that is not materially different from the estimate that would be obtained by using the present value basis of measurement.

iii. Contributions are made by the Club to an employee superannuation fund and are charged as expenses when incurred.

h) Inventories

Inventories consisting of house supplies are carried at cost.

Goods and services tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense.

Receivables and payables are stated with the amount of GST included.

The net amount of GST recoverable from or payable to the ATO is included as a current asset or liability in the balance sheet.

Cash flows are included in the statement of cash flows on a gross basis.

Commitments

Operating lease commitments

At balance date the Company had an Agreement for Lease with Transport for NSW. The Australian Accounting Standard AASB 16 - Leases - requires leases to be recorded on the Balance Sheet as non-current Right of Use assets (ROU) with an associated liability separated into current and non-current components. However, the Agreement for Lease is short-term and the Standard gives the lessee the choice of whether to recognise short-term leases on the Balance Sheet. The Club has elected to apply the short-term lease exemption to the Agreement for Maritime lease.

10. Segment Reporting

The Club operates in Australia providing Club facilities for the recreation of its members including a continuous water-based activity.

11. Subsequent Reporting

There are no events of a material and unusual nature likely, in the opinion of the Directors, to affect significantly the operations of the Club, the results of those operations, or the state of affairs of the Club in subsequent financial years not otherwise disclosed in this report or the financial statements.

12. Non- Current Liabilities

This amount represents:

- i. an amount of \$40,000 owing under a commercial hire purchase contract for kitchen equipment.
- ii. provision of \$14,773 for interest accrued on a top up loan provided by Archie Bear Pty Ltd; and
- iii. an additional amount of \$2,091 owing to Archie Bear Pty Ltd.

The parties are still in dispute as to the final loan amounts and interest payable thereon, which the directors consider is not material.
