President's Report

Dear Mosman Rowers Members.

It has been an unprecendeted year, and a year of re-openings. We continue to show our fighting spirit as we continue to survive and indeed thrive during these challenging times. We thank every Member and our wider Community for all their support and generosity during our second year. We especially thank our Life Members, our Community Partner Sponsors, Di Jones Real Estate, and all those who volunteer and support our Club. Next year looks to be an exciting one as we celebrate 110 years of the Rowers. Once restrictions lift we will share our plans to celebrate with all our members and guests.

During the year to 31st March 2021 the Board and Management have focused on the following:

- Complying with the terms and conditions of the Roads & Maritime Services (RMS) Agreement for Lease (AFL) and the Lease. Establishing systems for compliance with the Independent Liquor & Gaming Authority (ILGA) license requirements and the Registered Clubs Act.
- Securing a long-term lease with Mosman Council.
- Structural improvements to the Clubhouse including changing the air conditioning for the Building.
- Partnering with Sydney Harbour Surf Club to expand our paddling activities and deliver additional sporting benefits to our members.
- Establishing the relevant committees and advisory groups to ensure focus on key strategic initiatives and sustainable programs at the Club.
- > Enhancing our member enagagement and communication.
- Maintaining optimal membership numbers and driving membership growth.
- Reviewing the annual events calendar to foster sporting, social and family events.

As at 31 March 2021 total membership was 1,397 comprising a mix of established and new Members. During the period we saw over 1000 members join and renew, helped by the very successful 2 for 1 membership deal we offered to celebrate our 2 year anniversary. Further, due to the onset of COVID-19 we extended hundreds of membership expiry dates to recognise the impact of Club closures on members access to the Club, and to enable us to adopt a "wait and see" approach to the COVID impacts for the Club post March 2021. A key focus for us continues to be ensuring we engage and embrace our new and long-term Members into our Club so they can actively be part of the Mosman Rowers community and culture. The Social and Membership Committee has gone a long way to ensuring we better communicate, engage, and support our members. A special thanks must go to Julie Dalgiesh, a Life Member, who has dedicated countless hours to improving, managing and coordinating our membership program. Julie has great plans to make our process and systems better in the coming months, including a card solution for those of you who love cards!

We are grateful for our wonderful Rowers team, who have consistently worked hard through a rapidly changing period to deliver exceptional member experiences and ensure our Members feel comfortable in our home on Mosman Bay. I would also like to thank the wonderful management team, led at different times by our General Managers Justin Wolfs and Sam Curtis, who along with Emma & Adam Marshall of Bird & Bear, have overseen the further development of the Club in our second year of trading under the 'new era'. The key challenge was of course COVID 19 closing the Club for many months and then reopening as takeaway only and then reopening but with restrictions on numbers and style of operations. This was a very difficult period for staff who managed the process very professionally, returning to an energetic and fully engaged Club. Shane Mansfield is the new Group General Manager for the Bird & Bear Group, and has bought different backgrounds and skills, working with Adam and Emma and our Rowers crew to move the Rowers closer to our ultimate goal as being the best waterside Club on Sydney Harbour. We thank both Justin and Tristian Hope for all their hard work to get through the COVID period. We have been very excited to introduce our Dining Differently@The Rowers series, with degustation dinners matched with wines that showcase our various suppliers and our head chefs.

I also want to reiterate my personal thanks to the commitment, focus, support and hard work of all our Board members, each and every one has dedicated and invested significant time, energy and resources into the Club, continuing with forthnightly meetings and supporting each and every committee. I would also like to mention the various volunteers on our sub committees who made significant contributions above and beyond the expectations of anyone. Without our volunteers the Club would not have had such a successful second year and would not be set up so strongly for the future in Mosman Bay.

The Board has continued to meet regularly as we work towards achieving our vision of establishing the Mosman Rowers as THE key Community hub in the Mosman area. To this end, this year has been a great year of collaboration, seeing the Rowers really establish itself as part of the Mosman Bay broader community. We have established a wonderful relationship with the 3rd Mosman Bay Sea Scouts, which enabled us to replace our disfunctional sewer system. Our Grant strategy and submissions continue with several grants during the year including the replacement of our airconditioning and applying for solar power.

We have an on going collaborative relationshop with the Sydney Amateur Sailing Club, with new and exciting initiatives and activities being planned. We have partnered with Sydney Harbour Surf Club to encourage members to learn paddling. We are working with local environmental groups and the Council to enhance our Club and Mosman Bay, all while reducing our impact on the environment. This has included being partners with Council in a trial on recycling organic waste; recycling takeaway coffee cups and a subsidy for a solar feasibility study. We also participated in an EPA audit of waste management as part of their Bin Trim initiative. We have supported several local charity groups with fundraising functions and have hosted community forums for our local Federal Member.

Our Social Committee, led for most of the 12 months by Samantha Stevens, and now convened by Linda Holub, has helped us establish together with the Bird & Bear events team, a very full weekly schedule of activities for members and guests including the ever popular Friday night meat raffle and weekly trivia; special guest speakers at our series, In Conversation@The Rowers; monthly Jazz@The Rowers; weekly Bridge, health and fitness classes, dancing, community choir, mah-jong and more. We have celebrated Christmas, Australia Day, ANZAC Day, Mothers Day and other key occasions bringing members, friends and family together. Our monthly newsletter, Rowers Reel, is a great addition to keeping members informed about all the exciting things happening at the Club.

A special mention must be made to our resident Professor, Robyn Bushell, who has led the sustainability initiatives, the design and delivery of our Rowers Reel and the co-ordination of all grants for the Club, an absolutely incredible community icon.

Clubs are important avenues for people to come together, to feel welcome, to feel safe and to feel a sense of belonging. To this end, we ask you to think of your fellow members, your friends and your family who may be doing it tough and support each other, our members and our broader community.

After all, the Mosman Rowers is all about Community and bringing together young and old!

Thank you once again for being a member of our fabulous Club, and we look forward to seeing you all at the Club again soon.

Membership Report

As a Club, Membership remains a vital part of our financial, social and community viability. Between 1st April 2020 and 31st March 2021, over 1000 members renewed, or joined the Club. This is an incredible achievement. As of 31 March 2021, total membership was 1,397 with Members from Mosman and beyond, as far away as New York.

Member's Annual membership fees remained at \$99. Membership fees are essential to cover the Club's specific Member and corporate costs, such as voluntary workers insurances in addition to funding special projects such as equipment purchases, supporting sporting and social activities, and essential repairs to name a few.

The Board reviewed the membership structure in early 2020 and resolved to keep the simple annual membership fee of \$99 as the main offering. The Board also agreed to adjust membership expiry dates to account for the period during which the Club was closed during COVID and the fire. As such member's expiry periods were adjusted in the system. During the New Era Campaign composition of total membership has changed considerably with many new families joining and the Mosman Rowers continues to be very much a family-oriented Club offering a variety of sporting and social activities across a diverse age demographic. Over the past year we have seen this trend continue with many new families and young members joining the Club. Therefore the Board introduced two new membership categories, a Family Member (2 adults per household) and a Family Plus membership (4 adults per household). Unfortunately, due to COVID these programs have not been promoted fully, however the membership committee have been busy planning, the 2 for 1 membership deal in April, 2021 to celebrate our 2 year anniversary and the launch of another membership campaign for the latter half of 2021.

We will continue to work to attract new Members to the Club, to ensure the culture of the Club as family centred, community hub is preserved.

The Membership group continues to work to improve our membership system. We want to make it easier for our members to join and renew. Like all technological projects there are inevitable hiccups along the way, and we thank our members for their patience. It has proved to be a system that covers the majority of functions we need in an efficient and effective manner. We continue to work on plans to evolve the system and its integration into marketing, point of sale and other programs to enable us to better communicate with all our members, ensure we understand everyone's needs and provide the best member experience.

Members are reminded to download the *memberjungle* app, select Mosman Rowers as your Club and log in (using your email as your username) to ensure all your details are correct, and most importantly your date of birth to get your birthday voucher. About 30% of members have NO birthday in the system despite many emails and requests for such, so please, if you cannot access your account, next time you are down it the Club ask for Sam or one of our wonderful Rowers Crew to help you. The Member Jungle app can be scanned in the Club to get your member discounts.

A critical element of our success is for Members and their families to feel a sense of pride and belonging at the Rowers, a feeling that this is their Clubhouse. To achieve this the Board together with the Social and Membership Committee will undertake significant investment in developing and running member centric programs such as the Mosman Rowers fitness classes, art exhibitions, bridge, mah-jong, motorized sailing, paddling, and many more. We seek the support and help of our members to participate in these programs and ensure we continue to build a sustainable Membership-based Club at the Rowers.

We now have the very popular, monthly Jazz@The Rowers, featuring member Michael Connors Quartet; monthly Jamming with Jimmy (our very own and super talented Bar Manager); our guest speaker series In Conversation@The Rowers; and the Dining Differently@The Rowers, offering stunning themed degustation dinners matched with wines from various suppliers. The Social Committee also supports the special events like Melbourne Cup, Members' Christmas party, hosting around 100 members and families to a great Christmas party complete with Santa gifts for kids and bad Santa fun for adults; Australia Day, ANZAC Day, Mothers' Day and Fathers' Day.

We were planning cruises as part of Vivid and a big week of events for the 2021 Festival of Mosman, including an art exhibition, supported by Ken Done, however we will run the inaugural Art@The Rowers and the other activities in 2022.

Water Sports Report

The Mosman Rowers is a sports club, with our main sport being paddling. We are an associate member of Paddle NSW. We are delighted to have many members who regularly paddle in Mosman Bay in small groups, including the stand up paddle board group.

We were also very happy to announce a new partnership with Luke Horder and Sydney Harbour Surf Club to bring Rowers Paddling to the next level, and providing opportunities for Rowers paddlers to join many of the regular programs and fun paddling activities with SHSC at the Spit and Rose Bay, as well as special events in Mosman Bay. We want to build these activities. So we are looking for more members to join the Sports Committee and assist with the planning of a bigger and better calendar of events is the next 12 months.

We ran a number of other very successful water-based sporting events. In February we had an incredibly successful Rowers Family Fishing Day led by one of our stalwart members, and the Mosman Rowers Fishing Captain, Dennis O'Donohue. Perpetual trophies went to young Coby Reeves for the 'best catch of the day' and to Peter Briton for the 'biggest legal fish' and overall competition winner. Many other prizes including fishing rods, custom Mosman Rowers Club fishing lures, Club and BCF vouchers.

We had another successful radio-controlled sailing day for adults and a special kids school holiday workshop led by Norman Buckley our Sailing Captain, teaching our little Rowers how to race boats in the Bay.

The absence of a pontoon or fishing platform has made progress with more structured water-based activity slower, however the Club continues to work around these challenges, while continually looking for funding and innovative solutions. We have submitted a number of grants and will continue to look for solutions and funding. We are open to suggestions or any offers of help. memberships@mosmanrowers.com.au We have submitted a request to the Mosman Council as part of the Mosman Bay plan of management to provide kayak storage space and better water access from Harnett Park. We are also in discussion with 3rd Mosman Sea Scouts and Sydney Amateur Sailing Club for enhanced collaboration and support of our community-based activities on Mosman Bay.

We received funds through Zali Stegall, MP's office for water safety training and equipment for our volunteers, which will be activated in coming warmer weather.

Risk & Compliance Report

The Risk & Compliance Advisory Committee (RCAC) made some significant advancements during the 2021 Financial Year.

The RCAC was convened by Jeff Dalgliesh with Jules Dalgliesh as minutes secretary, 2 MRC Board Directors, Ashdown representatives as well as MRC member volunteers.

The RCAC covers all aspects of the Mosman Rowers Club but the key areas cover

- Liguor Act
- Registered Clubs Act
- Transport NSW (previously Roads and Maritime Services)
- Occupational Health and Safety

RCAC meets on a regular basis and the key objectives were to

- 1. Update Risk and Compliance Advisory Charter (successfully completed October 2020)
- 2. Centralise all key aspects of RCAC requirements in a centralised digital format to ensure (ongoing)
- 3. Ensure that MRC is up to date with its risk and compliance requirements.

An example of agenda items which are part of an ongoing list and incorporate our requirements include but are not limited to the following.

- The installation of a defibrillator at the front door of MRC.
- First aid training
- All aspects of food safety
- Review of Mosman Council and RMS lease agreements
- Review of Mosman Rowers insurance policies
- Fire and safety requirements.
- Incident log and report maintenance
- Maintain and react to Bird & Bear monthly venue audit checklist

There is a lot of work in progress on RCAC but we are confident that the momentum will continue.

Finally MRC and RCAC members would like to thank both Jeff and Jules Dalgliesh ,who have post balance date resigned, for their effort time and commitment throughout the 2020/2021 financial year.

Building Report

Without dwelling on the issues we faced as a Club in the past twelve months, the club house did receive some love and care, albeit less than planned. We had a clear direction and strategy outlined by the previous building committee however a number of the desired outcomes were pushed back with limited club access and a shift in priorities during the turbulent year. We still managed to upgrade the upper deck, which had caused as significant issues over the years, as well as complete the much needed air conditioning upgrade. A special thanks must go to Robyn Bushell who has worked tirelessly on our Government grants and has been very successful is getting us some much needed funds for these and future works.


Moving forward we need to realign and turn our focus back to the structural repair work that is part of our lease obligations, with pile replacement being the priority.

Grants Report

During 2020 and 2021 numerous relevant grants have been identified with several applications submitted. During this time we have used grant funds to purchase of a defibrillator, repair the leaking upper deck, replaced air conditioning, and repairs and upgrade the sewerage system (in the next financial year).

We are awaiting outcomes on other applications, although all grants are increasingly competitive with priority given to bushfire affected, and COVID affected regional areas. We acknowledge and are most grateful for the support of both Ms Felicity Wilson, MP, State Member for North Shore for funds through the NSW Community Building Program together with Scouts NSW, and to Ms Zali Stegall OAM, MP, Federal Member for Warringah, for funds through the Federal government Energy Efficient Communities fund and the Stronger Communities Program.

We continue to apply for State and Federal funds for maintenance work on piling supporting the building, solar panels, upgrading bathrooms and accessibility, creating a change room and accessible bathrooms, installing a fishing platform, improved gallery space, and artwork track and lighting system throughout the Club, improved fire protection for kitchen, repair leaking windows.

We also have applied for support from Mosman Council to ensure the Club is environmentally responsible. This includes keeping food waste out of landfill, moving away from use of single use food and drink containers, especially coffee cups and plastics and beautifying the approach to Club, and waste storage and delivery areas.

Our heritage building has high maintenance needs and is expensive to maintain. Over the last 3 years we have undertaken significant refurbishment of our sub structure and the Clubhouse, but we still urgently need to increase accessibility, complete substructure works and preserve the heritage of the building. The estimated cost of all the works is \$500,000 -\$700,000.

So in addition to applying for increasingly competitive grants, we now have the Mosman Rowers Club Future Fund in conjunction with the Australian Sports Foundation, enabling us to receive tax deductible donations. The fund is solely for ongoing capital projects and heritage preservation of the Clubhouse.

Some of the key capital projects we are seeking to fund include:

- 1. Repair/replacement of piles, and repair of northern side walkway and bracing of the building. Major cost and essential to our lease.
- 2. Installation of solar panels to reduce the power costs and improve our sustainability.
- 3. Accessible toilets and change room.
- 4. Lift access to the lower level.
- 5. An awning over the upper deck to reduce water egress and further damage to the building
- 6. Blinds on all north and south facing windows to reduce morning (Archie Bear café) and afternoon (Rowers Bar) sun and reduce reliance on air-conditioning.
- 7. Fishing platform/pontoon to provide water access for sporting activity.
- 8. Upgrade of the A/V system on all levels of the Club.
- 9. Beautification of the front of Club and a better managed waste area.

Directors' Report

The Directors have pleasure in presenting the Financial Reports of Mosman Rowers Limited (the Club) for the period ended March 31st, 2021, and the Auditor's Report thereon.

Apart from the above, no other matter or circumstance has arisen since 30 March 2021 that has significantly affected or may significantly affect the Club's operations, the results of those operations, or the Club's state of affairs in future financial years.

Notes to Accounts

1. Company limited by guarantee

The Club is a Company limited by guarantee under the *Corporations Act 2001*. The amount of Capital which is capable of being called up in the event of, and only for the purpose of, a winding up of the Club, is not to exceed \$10 per Member by virtue of the Club's Constitution.

2. Statement of significant accounting policies

The significant policies which have been adopted in the preparation of this financial report are:

a) Basis of preparation

The Financial Report is a general-purpose financial report which has been prepared in accordance with the Australian Accounting Standards and the Corporations Act 2001.

It has been prepared on the basis of historical costs and except where stated, does not take into account changing money values or current valuations of non-current assets.

The financial report has been prepared on a going concern basis, which contemplates continuity of normal business activities and the realization of assets and liabilities in the ordinary course of business. The going concern of the Club is dependent upon it maintaining sufficient funds for its operations and commitments. The Club made a profit of \$447,229 during the period ending 31 March, 2021, and the Directors are very pleased with this result given the difficult trading conditions during COVID-19. They have been conservative in the cash forecast for the next 12 months because of continuing uncertain economic conditions, however, the Directors believe that the Club will be able to continue as a going concern and as a result the financial statements have been prepared on a going concern basis.

b) Statement of compliance

The Financial Report has been prepared in accordance with the Australian Accounting Standards (AASBs) adopted by the Australian Accounting Standards Board (AASB).

c) Cash and cash equivalents

For statement of cash flows and balance sheet presentation purposes, cash and cash equivalents includes cash on hand.

d) Revenue recognition

Sales revenue

Sales revenue is recognised when the goods are provided, or when the fee in respect of services provided is receivable.

Subscriptions/Memberships

Subscription revenue is recognised in the period to which the membership relates.

Interest income

Interest income is recognised as earned.

Grant income

Interest income is recognised upon receipt of the grant monies.

Donations income

Donation income is recognised upon receipt of the donated monies.

Licence fees

Under the terms of the agreement the Club entered into with Ashdown (Archie Bear) Pty Limited in April 2019 there was a payment received for the sum of \$500,000 which was applied toward the costs associated with the new fit-out to the Club's premises. In accordance with Australian Accounting Standard AASB 15 - 'Revenue from Contracts with Customers' - the payment of this sum has been treated as the creation of a performance obligation. As the amount is non-refundable and the term of the agreement is for 10 years, then in accordance with the requirements of the Standard the revenue derived from the performance obligation will be recognised over the full term. The adoption of AASB 15 has resulted in a change in the treatment of the Deferred Revenue amount on the Balance Sheet. In the year ending 31 March 2019 the full amount of \$500,000 was shown as a Current Liability. With the change of accounting treatment only the revenue to be recognised in the 12 month period ended 31 March 2021 is treated as a Current Liability and the balance has been transferred to a Non-Current Liability account.

e) Income tax

No provision for income tax is necessary in respect of Club trading and investment income because the income is exempt from tax under the relevant provisions of the Income Tax Assessment Act.

f) Property, plant and equipment

Depreciation

Items of property, plant and equipment are depreciated using the straight-line method over their estimated useful lives. Assets are depreciated from the date of acquisition.

g) Employee benefits

- Liabilities for wages, salaries and annual leave are recognised for employee benefits in respect of employees' services up to the reporting date and are measured at the amounts expected to be paid when the liabilities are settled, plus related on-costs.
- ii. The liability for long service leave expected to be settled within 12 months of the reporting date is recognised and measured in accordance with (i) above.

The liability for long service leave expected to be settled more than 12 months from the reporting date is recognised but is measured based on remuneration rates current as at balance date for all employees and based on the probability of each of them achieving ten years of service.

The directors believe that this method provides an estimate of the liability that is not materially different from the estimate that would be obtained by using the present value basis of measurement.

iii. Contributions are made by the Club to an employee superannuation fund and are charged as expenses when incurred.

h) Inventories

Inventories consisting of house supplies are carried at cost.

i) Goods and services tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense.

Receivables and payables are stated with the amount of GST included.

9. Commitments

Operating lease commitments

At balance date the Company had an Agreement for Lease with Transport for NSW. The Australian Accounting Standard AASB 16 - Leases - requires leases to be recorded on the Balance Sheet as non-current Right of Use assets (ROU) with an associated liability separated into current and non-current components. However, the Agreement for Lease is short-term and the Standard gives the lessee the choice of whether to recognise short-term leases on the Balance Sheet. The Club has elected to apply the short-term lease exemption to the Agreement for Maritime lease.

10. Segment Reporting

The Club operates in Australia providing Club facilities for the recreation of its Members including a continuous water-based activity.

11. Subsequent Reporting

There are no events of a material and unusual nature likely, in the opinion of the Directors, to affect significantly the operations of the Club, the results of those operations, or the state of affairs of the Club in subsequent financial years not otherwise disclosed in this report or the financial statements.

12. Non- Current Liabilities

Unsecured Labilities refer to the Third-Party Loan to the Club from Ashdown Archie Bear Pty Ltd. At 31 March, 2021, this loan has been reduced by an amount of \$61,250 being Debt Defeasance agreed to by the Lender, and a further \$80,000 as an early repayment.

13. Other information

Mosman Rowers Limited is a Company limited by guarantee incorporated and domiciled in Australia. Its registered office and principal place of business is 3 Centenary Drive, Mosman, 2088, New South Wales.
