President's Report

Dear Mosman Rowers Members.

It is a pleasure to be able to reflect on our first full year of operations of the Rowers New Era. As Members, as a Club, as a Community we have come a long way from having to fight for survival including having to literally fight fires! We thank every Member and our wider Community for all their support and generosity during our first year. We especially thank our Life Members, our Community Partner Sponsors, Murchisons and Di Jones Real Estate, and all those who volunteer and support our Club.

During the year to 31st March 2020 the Board and Management have focused on the following:

- Establishing sustainable and viable operations in partnership with our retail operations management team, Bird & Bear.
- > Complying with the terms and conditions of the Roads & Maritime Services (RMS) Agreement for Lease (AFL) and the Lease. Establishing systems for compliance with the Independent Liquor & Gaming Authority (ILGA) license requirements and the Registered Clubs Act.
- Securing a long-term lease with Mosman Council.
- > Structural improvements to the Clubhouse including the substructure.
- Reviewing and strengthening our viable operating model with a professional operator to deliver Member benefits.
- Planning and executing a long-term water-based activities strategy, including the acquisition of a Mosman Rowers safety boat.
- Establishing the relevant committees and advisory groups to ensure focus on key strategic initiatives and sustainable programs at the Club.
- > Establish channels for member engagement and feedback.
- Rebuilding the Club post the voluntary administration period, including financial and operating systems, banking structure, sinking fund, compliance systems.
- New IT operating and reporting systems to improve the efficiency and accuracy of our data.
- New membership system to improve membership, enrolment, communication and renewal.
- > The ongoing review of our products and services to enhance Member satisfaction and engagement.
- > The recruitment and training of an entire new management and venue team to support Members.
- Maintaining optimal membership numbers and driving membership growth.
- Reviewing the annual events calendar to foster sporting, social and family events.

As at 31 March 2020 total membership was 1,397, comprising a mix of established and new Members. During the period we saw over 1000 members join and renew. Further, due to the onset of COVID-19 we extended hundreds of membership expiry dates to recognise the impact of Club closures on members access to the Club, and to enable us to adopt a "wait and see" approach to the COVID impacts for the Club post March 2020. A key focus for us continues to be ensuring we engage and embrace our new and long-term Members into our Club so they can actively be part of the Mosman Rowers community and culture. The Social and Membership Committee has gone a long way to ensuring we better communicate, engage, and support our members.

During the year, our members and the community continued to come together, but special thanks must go to the stalwart members of the Club who continually give their time and support to go above and beyond for the benefit of all members.

We are grateful for our wonderful Rowers team, who have consistently work hard through a rapidly changing period to deliver exceptional member experiences and ensure our Members feel comfortable in our home on Mosman Bay. I would also like to thank the wonderful management team, led at different times by our General Managers Matthew Murray, and Justin Wolfs, who along with Emma & Adam Marshall of Bird & Bear, have overseen the transition of the Club, in such a short one year period, from a broken Club on

the brink, to a vibrant, energetic and fully engaged Club. We welcome the arrival of Tristian Hope, the new Group General Manager for the Bird & Bear Group, an experienced chef and business owner who will work with Adam and Emma and our Rowers crew to move the Rowers closer to our ultimate goal as being the best waterside Club on Sydney Harbour.

I am also personally very grateful for the assistance of all our Board members, each and every one has dedicated and invested significant time, energy and resources into the Club, beginning with weekly Board meetings initially, then fortnightly with additional emergency meetings throughout the year. They have supported events, activities, sub committees and working groups with such positive enthusiasm and professionalism. I would also like to mention the various volunteers on our sub committees who made significant contributions above and beyond the expectations of anyone. Without our volunteers the Club would not have had such a successful first year and would not be set up so strongly for the future in Mosman Bay. Special mention must go to Professor Robyn Bushell for her incredible management of the Grant strategy and extensive work on grant submissions that saw us win several grants during the year including the Rowers Bar deck rebuild.

The Board will continue to meet regularly as we work towards achieving our vision of establishing the Mosman Rowers as THE key Community hub in the Mosman area. To this end, this year has been a great year of collaboration, seeing the Rowers really establish itself as part of the Mosman Bay broader community. We contributed to the Mosman Council Mosman Bay Plan of Management review. We have established a wonderful relationship with the 3rd Mosman Bay Sea Scouts, working together on joint grant applications for the benefit of all. We have created incredible collaborative opportunities with the Sydney Amateur Sailing Club, with new and exciting sailing initiatives and activities being planned for the next 12 months. We are working with local environmental groups and the Council to enhance our Club and Mosman Bay, all while reducing our impact on the environment.

As a community, navigating the evolving COVID-19 situation we must remember now, more than ever, that Clubs are important. They are Important avenues for people to come together, to feel welcome, to feel safe and to feel a sense of belonging. To this end, we ask you to think of your fellow members, your friends and your family who may be doing it tough and support each other, our members and our broader community.

After all, the Mosman Rowers is all about Community and bringing together young and old!

Membership Report

As a Club, Membership remains a vital part of our financial, social and community viability. Between 1st April 2019 and 31st March 2020 we had over 1000 members renew, or join the Club. That is an incredible achievement and of which we are incredibly proud.

Member's Annual membership fees remained at \$99 and have been budgeted essentially to cover the Club's specific Member and corporate costs, such as voluntary workers insurances in addition to funding extraordinary repairs or special projects such as essential equipment purchase, sporting materials, essential repairs to name a few.

The Board reviewed the membership structure in early 2020 and resolved to keep the simple annual membership fee of \$99 as the main offering. The Board also agreed to adjust membership expiry dates to account for the period during which the Club was closed during COVID and the fire. As such member's expiry periods were adjusted in the system. The Board further introduced two new membership categories, a Family Member (2 adults per household) and a Family Plus membership (4 adults per household). Unfortunately, due to COVID these programs have not been promoted fully, however the membership committee are already busy planning the launch of a membership campaign for the latter half of 2020 and early 2021.

During the New Era Campaign composition of total membership has changed considerably with many new families joining and the Mosman Rowers continues to be very much a family-oriented Club offering a variety of sporting and social activities across a diverse age demographic. Over the past year we have seen this trend continue with many new families and young members joining the Club. We will continue to attract new Members to the Club whilst ensuring the culture of our membership and the Club itself, is preserved.

The Club continues to work to improve our membership system. We want to make it easier for our members to join, renew or communicate with the Club. The Member Jungle app can be scanned in the Club to get your member discounts.

A critical element of our success is for Members and their families to feel a sense of pride and belonging at the Rowers, a

feeling that this is their Clubhouse. To achieve this the Board together with the Membership and Social Committee will undertake significant investment in developing and running member centric programs such as the Mosman Rowers Artists Series in the Gallery, Bridge Groups, Movie groups, motorized sailing boat groups, paddling, and many more. We seek the support and help of our Members to not only support these programs but to get involved and ensure we continue to build a sustainable Membership-based Club at the Rowers.

As of 31 March 2020, total membership was 1,397 comprising Members from all parts of Mosman and beyond, as far away as New York.

Social Report

We are delighted that our Mosman Rowers Social Committee has been established and have been meeting regularly since February. To ensure we were off to a good start the committee held a full day strategic planning session. We had exciting plans for the Rowers 1st year 'New Era' anniversary on March 15th, which unfortunately had to be cancelled due to COVID-19. The Committee has continued to meet very regularly with ANZAC Day marking the re-opening of the Club; Mothers' Day take home hampers which proved a great success and more recently, following easing of restrictions the return of the Friday night Meat Raffle [Now Meat and Veg]. A range of Club merchandise is now available for purchase at the Club and the range is to be extended.

Trivia has since returned with a weekly member special meal offering.

The Committee has been developing a number of initiatives and are looking forward to delighting members with an exciting agenda of social activities for young families (like school holiday craft activities; movie nights; a schedule of regular dinners with guest speakers on a wide range of topics; cruise dinners and much more.

They also are planning regular newsletters to keep members better informed and in touch.

A number of member activities had already commenced in 2019, but due to COVID most are on hold and yet to return. Book clubs, dancing, fitness classes, bridge, mahjong, art exhibitions are all planned.

Water Sports Report

The Mosman Rowers is a sports club, with our main sport being paddling. We are an associate member of Paddle NSW. We are delighted to have many members who regularly paddle in Mosman Bay in small groups. We completed a 2020 calendar of events early this year to include a number of larger Club wide initiatives including a water safety day, family day and fun races planned to commence in the next 12 months, but all have had to be put on hold due to COVID.

We did manage however to have a number of other very successful water-based sporting events, that has reinvigorated the committee and our volunteers. Now a bigger and better calendar of events is planned for the next 12 months post COVID. In October, we had an incredibly successful Rowers Family Fishing Day led by one of our stalwart members, and the Mosman Rowers Fishing Captain, Dennis O'Donohue. We had over 30 children and over 30 adults attend the event which was a huge hit, especially the prizes!. It was a huge success and we look forward to being able to announce another event soon.

Late last year we held our first Mosman Rowers radio-controlled sailing day to a wonderful response led by Norman Buckley our Sailing Captain. Norman and his crew spent hours rigging radio-controlled sailing boats and teaching our little Rowers how to race boats in the Bay. The event was such a success the Club has invested in 2 boats that we will get branded and we are planning to hold regular races in the Bay for all sailing enthusiasts, young and old.

The absence of a pontoon or fishing platform has made progress with more structured water-based activity slower, however the Club continues to work around these challenges, while continually looking for funding and innovative solutions. We submitted a number of grants last year and will continue to look for solutions and funding this year. We are open to suggestions or any offers of help.

Additionally, we have submitted a request to the Mosman Council as part of the Mosman Bay plan of management to provide kayak storage space and better water access from Harnett Park. We are also in discussion with 3rd Mosman Sea Scouts and Sydney Amateur Sailing Club for enhanced collaboration and support of our community-based activities on Mosman Bay.

We received funds through Zali Stegall's office for water safety training and equipment for our volunteers, which will be activated in coming warmer weather.

Risk & Compliance Report

The Risk and Compliance advisory group has a significant remit, and this year we have focused on developing a charter for the volunteers, producing a Whistle blower policy, a Privacy statement and starting a framework across the key areas of focus for the operation being, Work Health and Safety, Registered Club Act and Liquor Act compliance, as well as RMS and Council lease compliance.

The group met quarterly last year however will meet more frequently post COVID, to further flesh out a framework and action plans.

Building Report

The Building Committee, led by Chair, Geraldine Rietbergen, continue to focus on strategic needs of the club house. After working tirelessly last year, to ensure the appropriate structural repairs and restorative activities were proactively managed, this year the focus has turned to developing a strong repairs and maintenance plan and focusing on the additional lease compliance activities required in 12 months time.

During this period the following building works were undertaken for the Club including but not limited to:

- the completion of the Gallery space with newly sanded floorboards
- the restoration and installation of the heritage lighting on the front eastern balcony
- the upgrade to the fire system to have a back to base response system
- the repairs to the upstairs and lower ground floor due to fire damage
- the replacement of the damaged carpeted area upstairs
- the complete replacement of the Rowers bar deck
- the completion of the front entrance garden
- the installation of additional fire safety systems in the kitchen
- the installation of acoustic sound panels in the lower ground floor area.

Under the RMS lease obligations there are some additional substructure repair work that will need to be completed in the coming 14 months however the Board is actively managing this with the Building committee to ensure we manage expectations given the potential COVID impacts. There are a number of Initiatives the Board would like to undertake to make our Club more accessible to the broader community and to enable better access to the water, and so have submitted a number of grant applications to complete this work. We thank all the Members in advance for their support of our building initiatives and for patience when any building works are taking place.

The Board has started a CAPEX register for future repair work. This will be reviewed and updated Quarterly, and the Board will prepare some strategic plans for the funding and fundraising of the essential works.

Grants Report

During 2019 and early 2020 numerous relevant grants have been identified with several applications submitted.

To date we have applied for State and Federal funds for maintenance work on piling supporting the building, upgrading bathrooms and accessibility, creating a change room, repairing and upgrading the sewerage system, installing a fishing platform, purchasing a defibrillator, gallery space fit out; acoustic panels for café, improved fire protection for kitchen, repair leaking windows, repairing the leaking upper deck and replacing air conditioning. Funds have been received for the defibrillator (\$1,300), and deck repairs (\$43,992). We are awaiting outcomes on others, although we grants are increasingly competitive and many now prioritise bushfire affected and more regional areas. We acknowledge and are most grateful for the support of both Ms Felicity Wilson, MP, State Member for North Shore and Ms Zali Stegall OAM, MP, Federal Member for Warringah.

We also have applied for support from State and Federal Grants and partnerships with Mosman Council to ensure the Club is environmentally responsible. This includes a move to low energy air conditioning and heating, keeping food waste out of landfill, moving away from use of single use food and drink containers, especially coffee cups and plastics and beautifying the approach to Club, waste storage and delivery areas.

Directors' Report

The Directors have pleasure in presenting the Financial Reports of Mosman Rowers Limited (the Club) for the period ended March 31st, 2020, and the Auditor's Report thereon.

We are pleased with the result for the year, being an operating profit of \$160,386 (\$41,555 loss for 2019), which includes a fee of \$50,000, being part of a Licence fee to manage the retail operations of the Club, and which has enabled us to do a large scale renovation of the Clubhouse.

Notes to Accounts

1. Company limited by guarantee

The Club is a Company limited by guarantee under the *Corporations Act 2001*. The amount of Capital which is capable of being called up in the event of, and only for the purpose of, a winding up of the Club, is not to exceed \$10 per Member by virtue of the Club's Constitution.

2. Statement of significant accounting policies

The significant policies which have been adopted in the preparation of this financial report are:

a) Basis of preparation

The Financial Report is a general-purpose financial report which has been prepared in accordance with the Australian Accounting Standards and the Corporations Act 2001.

It has been prepared on the basis of historical costs and except where stated, does not take into account changing money values or current valuations of non-current assets.

The financial report has been prepared on a going concern basis, which contemplates continuity of normal business activities and the realization of assets and liabilities in the ordinary course of business. The going concern of the Club is dependent upon it maintaining sufficient funds for its operations and commitments. The Club made a profit of \$160,386 during the period ending 31 March, 2020. Notwithstanding this result, the Directors are conscious of the potential impacts of COVID-19 on the trading, however based on budgeted cash forecast for the next 12 months which reflect the estimated COVID-19 impact, the Directors believe that the Club will be able to continue as a going concern and as a result the financial statements have been prepared on a going concern basis.

b) Statement of compliance

The Financial Report has been prepared in accordance with the Australian Accounting Standards (AASBs) adopted by the Australian Accounting Standards Board (AASB).

c) Cash and cash equivalents

For statement of cash flows and balance sheet presentation purposes, cash and cash equivalents includes cash on hand.

d) Revenue recognition

Sales revenue

Sales revenue is recognised when the goods are provided, or when the fee in respect of services provided is receivable.

Subscriptions/Memberships

Subscription revenue is recognised in the period to which the membership relates.

Interest income

Interest income is recognised as earned.

Grant income

Interest income is recognised upon receipt of the grant monies.

Donations income

Donation income is recognised upon receipt of the donated monies.

Licence fees

Under the terms of the agreement the Club entered into with Ashdown (Archie Bear) Pty Limited in April 2019 there was a payment received for the sum of \$500,000 which was applied toward the costs associated with the new fit-out to the Club's premises. In accordance with Australian Accounting Standard AASB 15 - 'Revenue from Contracts with Customers' - the payment of this sum has been treated as the creation of a performance obligation. As the amount is non-refundable and the term of the agreement is for 10 years, then in accordance with the requirements of the Standard the revenue derived from the performance obligation will be recognised over the full term. The adoption of AASB 15 has resulted in a change in the treatment of the Deferred Revenue amount on the Balance Sheet. In the year ending 31 March 2019 the full amount of \$500,000 was shown as a Current Liability. With the change of accounting treatment only the revenue to be recognised in the 12 month period ended 31 March 2021 is treated as a Current Liability and the balance has been transferred to a Non-Current Liability account.

e) Income tax

No provision for income tax is necessary in respect of Club trading and investment income because the income is exempt from tax under the relevant provisions of the Income Tax Assessment Act.

f) Property, plant and equipment

Depreciation

Items of property, plant and equipment are depreciated using the straight-line method over their estimated useful lives. Assets are depreciated from the date of acquisition.

g) Employee benefits

- Liabilities for wages, salaries and annual leave are recognised for employee benefits in respect of employees' services up to the reporting date and are measured at the amounts expected to be paid when the liabilities are settled, plus related on-costs.
- ii. The liability for long service leave expected to be settled within 12 months of the reporting date is recognised and measured in accordance with (i) above.

The liability for long service leave expected to be settled more than 12 months from the reporting date is recognised but is measured based on remuneration rates current as at balance date for all employees and based on the probability of each of them achieving ten years of service.

The directors believe that this method provides an estimate of the liability that is not materially different from the estimate that would be obtained by using the present value basis of measurement.

iii. Contributions are made by the Club to an employee superannuation fund and are charged as expenses when incurred.

h) Inventories

Inventories consisting of house supplies are carried at cost.

i) Goods and services tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense.

Receivables and payables are stated with the amount of GST included.

The net amount of GST recoverable from or payable to the ATO is included as a current asset or liability in the balance sheet.

Cash flows are included in the statement of cash flows on a gross basis.

The Club has elected to apply the short-term lease exemption to the Agreement for Maritime lease.

10. Segment Reporting

The Club operates in Australia providing Club facilities for the recreation of its Members including a continuous water-based activity.

11. Subsequent Reporting
